

Dear Sirs:

Re: Newspaper Vendors and Criminal Charges of Causing a Disturbance by Impeding

I am writing to you in regard to what appears to be a serious lack of legal knowledge on the part of members of the Metropolitan Toronto Police Force.

On the 20th day of August, 1971, I appeared on behalf of Mr. Thomas Vassal before His Honour Judge Camblin in 26 Court at the Old City Hall. Mr. Vassal was charged with causing a disturbance by impeding while selling the newspaper "Guerilla" on Yonge Street.

The police evidence at the trial indicated that Mr. Vassal had impeded several persons on Yonge Street while selling the newspaper but there was no evidence presented by the police of any disturbance being caused by Mr. Vassal's actions. The police officer who testified in the case, Edward Adamson, when asked what was required for a charge of causing a disturbance by impeding stated that if a person impeded another person on the street that was sufficient.

Needless to say, Mr. Vassal was acquitted of the charge. A similar charge against another Guerilla vendor, John Larson, which was to be heard on that day and involved P.C. Adamson was then withdrawn at the request of the Crown.

If it were only a question of the lack of legal knowledge of P.C. Adamson I would not be writing you at this time. However, on August 26th, 1971, while walking at the corner of Queen and Yonge Street I saw another police officer talking to a Guerilla vendor. After intervening it became apparent that this police officer also was under the misapprehension of the meaning of the charge: causing a disturbance by impeding. After discussions with the officer the vendor was allowed to continue selling the paper.

I think it important that you take steps to ensure that all the police officers in the downtown area who might have contact with newspaper vendors are aware of the legal requirements for a charge of causing a disturbance by impeding.

Reply: Mr. William Lee is entitled to his pleasure, and much good may it do him. But he may be less pleased when and if he reads this issue – wherein we cover the Ottawa and Vancouver Gay Action rallies in full. We hope Guerilla readers understand it's through our COVERAGE that we express our interests and attitudes.

To the Guerilla Staff:

As a reader of your paper—and a sometimes contributor—I feel it's about time I said something about its authoritarian (specifically Marxist) leanings. They're to be expected of course, given the prevailing altruistic-collectivist drift of morality and political thought in this society, but sad none the less, to see an enti-establishment paper (albeit one subsidised by the federal government) settle for the discredited cliches of socialist authoritarianism.

You run a column called "Marx U.", which ponderously explains Marxian theology to the unconverted. May I suggest taht Marx U. should be burnt to the ground. Michail Bakurin, Marx's anarchist opponent in the First International, saw very clearly the bloody tyranny that Marx's political principles would lead to if they were ever applied—in Russia, China, Eastern Europe, and Cuba—with precisely the grisly results Bakunin predicted. Yet People who should know better (including you people) are still taken in by the Marxists' claim that the horrors of socialism are mere accidents, that 'true Marxism' would be all

people should *ideally* be tree to do whatever they wish so long as it doesn't involve fraud or force against others. It is a philosophy of political liberty and ethical individualism in the tradition of Stirner, Spencer, Nietzsche, Bakunin, Kropotkin, Benjamin Tucker, Lysander Spooner, Carpenter, Emma Goldman, H.L. Mencken, Paul Goodman and Ayn Rand. A Marxist wants to force people to sacrifice themselves to what he regards as a higher good. I want people to leave me alone. That's the basic difference between us.

I was most amused to read, in the column Bear's Lair, your listing of 'Liberty, Equality, Fraternity, and Truth' as Left Wing, and 'Rigid Conformity, Independence, Wealth Greed, Hypocricy, and Tyranny' as Right Wing. I suppose

the possession of such a naive and simplistic view of the world must have its joys, but from the outside looking in, it seems fatuous in the extreme. Liberty and Equiaity are incompatible: free men are not equal and the only way to make them equal is to chop off the heads of those who stand above the crowd, the sacrifice of the superior to the commonplace. Fraternity, it seems to me, if it is to be true fraternity and not just a cheap slogan to excuse iniquities, can not be based on force, even 'mild' force-it must be peaches and cream and pie from the sky. Socialism, in even its milder forms, is nothing of the sort. As H.L. Mencken said of the New Deal, "it began, like the Salvation Army, by promising to save humanity, and ended, again like the Salvation Army, by running flop-houses and dusturbing the peace." For socialism, and all statism, is after all dependent on initiated force (such as taxation, trade restrictions, expropriation, censorship, moral laws, the draft, welfare, etc.). In contrast, Capitalism, which your paper condems, is a system of voluntarism, of consentual relationships, among individuals-a far more attractive way of life, to my mind.

My own position is a libertarian one—that is, I think voluntary; under socialism, it is anything but voluntary. Truth, well, lest leave Truth for the moment.

The Right, claims the Bear (Russian Bear?) from his Lair, is the province of 'rigid conformity.' But the whole tenor of our society now it leftist of one variety or another. Every conformist in sight mouths the same altruistic platitudes—all based on the Lester Pearson syndrome: "Take from A and give some of it to B so B will think what a good guy you are." It seems to me that it's the demand for forced equality, compulsory fraternity and a monopoly on truth that's rigidly conformist!

In the Bear's system of morality, if I have 'independent'—earned— wealth and someone wants to take it away from me, I'm 'greedy' and he's a champion of human equality! 'Greed' of course, is merely others' wanting more of what we want—just as 'vice' is the pleasure of others.

A couple more extracts from your pages and I'll go. Carl Whitman, in his 'Gay Manifesto' refers to 'the exploitation of minorities by capitalism.' In fact, it is only the operation of the free market (and its basis, the free mind, and corollary, the free press) that has allowed minorities to advance, in spite of prejudice and government restrictions against them. (The Jews, of course, are the best example of this—their capitalistic successes were used by tyrants like Hitler and Stalin to whip up envy and hatred in the mob and perpetuate their own power.) It's interesting that later in Whitman's article, he advocates setting up independent gay institutions and services—which of course would be examples of the capitalism (laissez-faire, co-operativism, voluntarism, anarchism—call it what you will) that he thoughtlessly condemns in principle.

And Doug Austin's complaint in another column about the government enforced food franchise on the Islands points up an excellent example of government restriction creating a bad situation that capitalism would remedy by opening up the Island to other food vendors, including health-food dealers. (Leftists of course claim to oppose 'monopolies'—yet their 'solution' is one big government monopoly with a gun in its hand—or at leat some kind of authoritarian restrictions as to who can do business and on what terms. Something wrong with the logic here!)

At any rate, I suggest you people 'check your premises' before you sink any deeper into the altruistic-statist-collectivist mire. You might even read some of the libertarian authors I mentioned: Ayn Rand is particularly pertinent (especially "Atlas Shrugged" and "The Virtue of Selfishness) and H.L. Mencken particularly enjoyable (especially "A Mencken Chrestomathy"). It was Mencken who described democracy as the art and science of running the circus from the monkey cage, defined immorality as "the morality of those who are having a better time" and said he was against slavery simply because he disliked slaves. A most salty and amusing old character—and a good deal more fun than Karl Marx!

LA PRESSE LOCKOUT

La Presse, Montreal's principal French language newspaper, has threatened to fire any of its locked-out employees involved in a brawl that caused about \$7,000 worth of damage to the Portage Golf Club in L'Assomption, 30 miles northeast of Montreal.

About 40 men invaded the club where La Presse department heads were holding a banquet following their annual golf tournament. Six men were injured.

Philip Moreau, the club accountant, said, "There was broken glass everywhere and bloodstains on the chairs, tables and walls. Chairs and bottles were used, and plates of roast beef were scattered everywhere. The fight must have lasted about 12 minutes."

About 350 stereotypers, pressmen, mail-room personnel, typographers, and photoengravers were locked out by La Presse last July 19 as the strike deadline set by the Quebec Federation of Labor, which represents the workers, approached. The workers, who had been without a contract since January 1, 1971, had made little headway in negotiation with the newspaper in forestalling plans for automation which would result in massive layoffs of craft union employees.

Police say about 25 of the "invaders" were recognized to be locked out La Presse workers, but no arrests had been made. The OFL was unavailable for comment, on the incident

The Montreal Police Brotherhood, the Quebec Federation of Labor, and the Quebecois have announced that they will refuse to supply the newspaper with information as a show of support for the locked-out employees.

The labor federation has been denying La Presse scab reporters admittance to their meetings and news conferences since August 22. All their statements sent to newspapers by telegraph are; 'To the attention of all media except La Presse.'

Following the incident at the L'Assomption banquet, La Presse obtained a temporary restraining order against the four unions involved, forbidding them to harress or threaten strikebreakers or to try to prevent delivery trucks from leaving the shipping area.

La Presse has been hiring Hertz trucks for delivery purposes, and these are escorted on their rounds by two taxicabs, one in front and one behind, each with a burly, intimidating driver.

The injunction expires September 8, at which time the newspaper plans to request an interlocutory injunction of the same nature against the unions.

The QFL says it plans to continue massive demonstrations in front of the La Presse building in defiance of the injunction.

terror at san quentin

There seems to be an air of hostility here. I don't understand why we can't do this in a calm, dispassionate manner... In my opinion this is not a normal courtroom scene.

Judge Carl Allen in court on Thursday Aug. 26 hearing for the Soledad Brothers.

SAN QUENTIN (LNS)-George Jackson finally escaped from San Quentin in a "meat wagon" just as he predicted he would. His body, minus the mythical knit cap which they said he'd been wearing, minus the mythical wig their new story claimed he wore, rode out at the end of a line of meat wagons. First came the hearse, carrying two bodies, next a lpael truck and last the station wagon. His body carried two very real bullets — one in his back and (because that bullet didn't work) one in his head.

Since the announcement of George Jackson's death, the prison officials' explanations have become more and more complicated. Police are still looking for Stephen Bingham, a young radical lawyer who supposedly smuggled in the gun he supposedly used. George, they said, got the gun back to his cell by hiding it in his hair. "George had light hair and you could see his scalp," said a former prisoner who knew him in Soledad Prison. "For them to give us that ridiculous story that a gun was put in his hair is absurd."

The prison officials next hooked onto the idea that he hid the gun under a knitted cap which they claimed he had recently started wearing. When that sounded fishy, they changed to a wig. They claimed they found this wig concealed in his cell.

"I'm not going to let them smear him, kill him and cover it up and sweep it under the rug," said Mrs. Georgia Jackson, his mother. "I'm not going to let them get away with that"

Thursday morning, five days after George Jackson was killed, San Quentin officials allowed lawyers who had prisoners with cases pending to go in. When they left they passed through lines of guards armed with submachine guns to talk to the people waiting on vigil outside. The vigil had started as soon as George's death was announced.

"Right now there is an absolute reign of terror in that prison," said one lawyer. "Everyone I saw was black or Chicano and without exception they were told, 'Nigger, you're going to be dead before this is over."

The prisoners who were caged on the first tier had been moved to the second tier. George was kept on the first tier and the prisoners there had signed a statement which told of the beatings since his murder. They are now living two to a cell with one mattress and two blankets per cell. Their daily diet consists of four sandwiches and an apple. They get water if they are lucky. They have no shoes or socks; no toothpaste or toothbrush.

According to a lawyer, Ruchell Magee

had been very badly beaten. He had a five inch lump on his head and marks on his ribs, shoulders and arms. His lip was cut. He was dehydrated because he hadn't had any water in four days. He seemed as if he was in shock. "His spirit is pretty well broken in one sense," said the lawyer. "But somehow he continues to function and continues to resist what they are trying to do to him."

Ruchell sent a message with him which said in part, "I have fought to expose that fraud conviction and the conspiracy against me. For my efforts courts have denied me my rights, refused to hear me, refused to listen to my petition. The state of California...has decided and attempted to execute me by legal means. Because I have resisted that and I have exposed their acts they have attempted to execute me by armed might."

Another prisoner, Earl Gibson, was beaten so badly his eyes rolled back and he drolled uncontrolably. He can't talk or feed himself. He is now in the hospital.

Alan Mancino had been lying in the courtyard with the 25 other prisoners right after George was killed. The guards were holding guns to them and warned them not to move. After about two hours, the handcuffs were completely cutting off circulation in his hands. A guard came up and said, "I told you not to move," and shot him in the leg. The guard said, "Oh, my gun went off by accident." Another guard commented, "No, no, he was trying to escape — we got 40 witnesses here." No one knows where Mancino is.

When Judge Carl Allen walked in, he remarked, "I've been calm since January 16 1970, [the date when the Soledad Brothers were accused of murdering the guard]."

Attorney Richard Silver stood to offer proof that Fleeta and John had been beaten since their last hearing the day before. John had large bruises on his face and Fleeta had cigarette burns on the side of his neck.

District Attorney Curtis claimed that it was all propoganda and there were no beatings.

Fleeta cried out, "You want to see the burns? If you're going to kill me, kill me, now. Fuck all this shit!" Fleeta's mother-Mrs. Williams started crying and ran out of the room.

Silver pleaded to have a doctor look at Fleeta immediately.

The prosecutor said, "This is all irrelevant to the proceedings at hand."

REIGN OF TERROR CONTINUES AND CONTINUES AND CONTINUES

"After the first hearing, we were only allowed five minutes with our clients yesterday, with guards in the room all the time," Silver told the judge. The law requires the presence of the defendants in any court proceeding. Presence means not just physical but being mentally able to participate. This is impossible when every time they leave the courtroom the defendants are being tortured and burned with cigarettes by the guards."

The DA denied it was happening. "It's all falsehoods," he said.

By this time Fleeta was visibly shaking. There were angry mutterings from the crowd

Judge Allen insisted on getting on to the motions that they were there to present.

Silver asked for a postponement until Monday so they could get medical care for their clients.

"I don't see any bruises," commented Allen. Fleeta took off his shirt to show him.

"Maybe if you see bruises it depends on your point of view," Allen said. "It, depends on whether you're looking for them or not,"

John Thorne, George Jackson's lawyer shouted from the spectator's section that Allen had jurisdiction over prisons and he could do something about what was going on in San Quentin. Thorne couldn't sit with the other defense lawyers since as Allen put it, "You're no longer an attorney because you don't have a client, because your client is dead." Judge Allen replied that he should be quiet or else he would be thrown out of the courtroom.

"This isn't a courtroom — this isn't a court of justice and I'm leaving anyway," Thorne said as he walked out.

Allen continued to deny all motions for medical care for the prisoners and wouldn't issue a restraining order to prevent guards from beating prisoners.

Mrs. Maxwell started crying and called the judge a son of a bitch.

Then from nowhere the tactical police in full riot gear appeared to remove her from the courtroom. They carried with them a new weapon. Instead of a rounded club they carried a sharp, curved one which looked something like a boomerang.

A group of people tried to protect Mrs. Maxwell from being removed. The tactical police lunged for them and started beating heads. "They were the most brutal clubbings I have ever seen not only in any courtroom but in any riot scene or in any demonstration," said one woman who was there.

They seemed to aim at the black men in particular. Phil Price, who has been active in the Soledad Brothers Defense Committee was on the ground with a tactical squad on him constantly jamming his club into him. They had his leg over a wooden seat and were clubbing it trying to break the leg or smash the knee. By the time they pulled him off the ground, "he was streaming with blood - there wasn't one inch of him that wasn't covered with blood," gasped one observer. Finally Price and his brother Marty were taken to the lock up and beaten while a submachine gun was pointed at their heads. They were both charged with assault. By the time the hearing started again there was blood splattered on the floor and eight feet up along the rear wall.

profile: helen roedde

Helen Roedde is the NDP candidate for the Ontario legislature in the Toronto Bellwoods riding. Mrs. Roedde, who has 2 children, has been a social worker for 21years.

From afternoon to late evening, she and her small army of volunteers, mostly male, can be found pounding the doors of the riding, canvassing for support. The canvass is the only political tactic being employed by Mrs.. Roedde, who likes "person-to-person politics". Meetings and rallies, she says, are gatherings of the faithful, and do not expand her support.

Being a woman candidate may have its drawbacks in other areas, but Mrs. Roedde views it as being beneficial. Pointing out that the Bellwoods riding is a principally immigrant community, she says, "Europeans feel

that if a woman has the motivation to leave the home, she must have enough drive to do a good job. They trust a woman more than they do a man, of whom they suspect a power motive."

"Once I stopped in a store while canvassing, to get something to drink. I handed the store owner a leaflet, and he didn't seem too interested. Then a little while later he saw me going up and down the street, pounding on doors and talking to people. He came over to me and said, "You really want the job, don't you?"

According to Mrs. Roedde, the new, lower voting age is a plot to maintain the WASP control in areas inundated by new immigrants. Immigrants cannot become citizens until they are 23, so cannot vote until then. The new legislation puts more English-

Canadians on the voting lists, while holding down whole communities of immigrants.


In the Roedde Campaign Headquarters, at 299 Harbord Street, only one campaign brochure was to be found. Along with it were literature and pamphlets on detection of breast cancer, job opportunites for students and various available government services. Several times during our interview, young canvassers delivered reports and were assigned new functions. The Roedde machine is simple and works well apparently.

The candidate seems, however, amazingly unclear on the politics of her party, and on the degree to which to she agrees with them. She carefully avoided comment on the NDP's proposed public auto insurance program, and other specific positions taken by the NDP leadership. Stimulated to run by

increasing unemployment, she still favoursi curtailment of American investment in Ontario. Her solution is an Ontario Development Corporation, but as to where it would obtain the capital, she is uncertain.

Another major problem with which she is concerned as a social worker is public housing. "People should be able," she says, "to sit down with an architect, and discuss just what type of project they want to live in." When asked about the potential cost increase over present public housing programs, she was again unclear, saying: "Let's try it and see what happens."

Someone whose political heroes are as diverse as Alderman John Sewell of Toronto, and ex-Highways Minister Joe Borowski of Manitoba can't be all bad.

After making his way to the Chilean border, Father Leo told reporters: "I saw men, women and children mown down. My conscience rebelled and suddenly my opposition to violence seemed irrelevant."

J. Edgar leaves murderers for arsonists

WASHINGTON-J. Edgar Hoover, director of the U.S. Federal Bureau of Investigation, reported that 65% of murders in the United States were accomplished with guns, and that one in four murders was the result of a family feud or broken friendship.

As a result, Hoover said, murder has largely become "a national social problem beyond police prevention."

RICHMOND, VA.-The Virginia Supreme Court says there is no war in Vietnam, because the U.S. Congress has not declared one.

Reversing the ruling of a lower court, it ordered insurance benefits paid to a grand-mother of a soldier killed in the wreck of a military vehicle in Viet Nam.

The policy had carried an exclusion against death "by war or any act of war suffered" while in military service.



OTTAWA—The first Canadian Gay Action rally took place August 28th in the nation's capital. A list of 10 demands, printed elsewhere in this paper, were presented. Over 100 protestors marched through a steady downpour about Parliament Hill.

The rally was held in support of a brief demanding an end to all laws which perpetrate civil discrimination against Canada's homosexual population. Sociologists have placed this population at NOT LESS THAN 1.4 million, and as Charles Hill, former chairman of UTHA, said, the Ottawa March had historic significance. Hill added that "2 million homosexual men and women in Canada are watching us."

The Rally's coordinators, including coauthors of the 13-page brief, were the Toronto Gay Action. We received the solid backing of gay organisations across the nation. These included: Community Homophile Association of Toronto, Le Front de Liberation Homosexual (Montreal), Gay Alliance Towards Equality (GATE; Vancouver), Guelph University Homophile Association, University of Toronto Homophile Association (UTHA), Vancouver Gay Activist Alliance, Vancouver Gay Liberation Front and Gay Sisters, Waterloo University Gay Lib Movement, and York University Homophile Association.

In speaking to the Rally, Charles Hill observed:

"Two years ago the Criminal Code amendments came into effect. After months of debate, during which ignorant Members of Parliament amused themselves making anti-homosexual jokes and flaunting their religious and sexist bigotry, sexual acts between two consenting persons over 21 were made legal in private. All this did was to bring the law into line with police practice."

To this end it becomes clear how we, as gay people, have much consciousness raising to do among our own brothers and sisters. Blacks remained slaves for over 300 years because very few interpreted their bondage as oppression and worked to change things. How many gay people are there who maintain a similar mentality?

As long as their luck holds out and they themselves do not fall under the ax of blatant persecution, they accept the ghettoised and fragmented life-style and uphold the status quo. With these things in mind, the UTHA was formed in October, 1969.

The Ottawa march was a point of solidarity in our continuing struggle with all elements of sexist oppression. As George Hislop of CHAT told the demonstrators:

"There is no law against being a homosexual and there never has been. Homosexuals are oppressed simply because they are not heterosexuals. No one need be nor should be ashamed of their sexuality."

From the tenor of these remarks, it is obvious that our activism is pledged to liberating the repessive consciousness of gays and straights alike. For Gay Lib is people's freedom. Freedom to Love, to communicate your love in all ways, physically and intellectually, without fear crushing the spontaneity and fullness of your expression. Gay Lib is making your sexuality more of an honest aesthetic response, rather than just another conditioned reaction.

It is this conditioned reaction into which you are pressured by straight society. Gay Lib is demonstrating that there is not just one life style in which everyone should seek self-identification through cliche responses and actions.

In fact, the Gay Lib movement in an intelligent, sensitive part of man's total liberation from the ancestral irrationality of rules — which were assimilated blindly, without personal evaluation, and which resulted in man's self-enslavement.

While protesters proudly chanted "2-4-6-8, Gay Is Just As Good As Straight!" and "Say It Loud, Gay Is Proud", Charles Hill's words proclaimed that Canada's Gay Liberation movement is no longer willing to hide our love away. It is no longer willing to accept the multitude of discriminations which pervade straight society. To this, Hill said:

"We're fed up with the lack of respect due all human beings. We're fed up with the genocide of gays fostered by psychiatrists using medieval tortures to destroy us. We're fed up with being discriminated against in employment, housing and the courts, We're fed up with being arrested and harassed by police forces paid for by our taxes.

"In fact, we're fed up with paying the price of other people's hang-ups. No longer are we going to accept the lie foisted on us that there is a homosexual problem in Canada. There is no homosexual problem. There's a heterosexual problem!"



Several of Parliament's usual RCMP guards, fully caparisoned, looked on grimly through the entire Rally. The hope of Gay Lib is directed at the unification of all human beings no matter what their philosophy through recognition of homosexual rights and for equality without the division of society into classes.

We seek the support of all society in our struggle to defeat injustice, and for more understanding.

VANCOUVER-Simultaneously with the Ottawa Rally, 20 members of GATE held a Rally in front of Vancouver's Court House. Nearly 200 onlookers, mostly sympathetic heard people from GATE, GLF and Gay Sisters, as they read the demands of the brief which was being presented in Ottawa.

WE DEMAND:

1. the removal of the nebulous terms "gross indecency" and indecnet act" from the Criminal Code and their replacement by a specific listing of offences, and the equalization of penalties for all remaining homosexual and heterosexual acts; and defining "in private" in the Criminal Code to mean a "condition of privacy";

2. removal of "gross indecency" and "buggery" as grounds for indictment as a "dangerous sexual offender" and for vagrancy;

3. a uniform age of consent for all female and male homosexual and heterosexual acts;

4. the Immigration Act be amended so as to omit all references to homosexuals and "homosexualism";

5. the right of equal employment and promotion at all government levels for homosexuals;

6. the Divorce Act be amended so as to omit all references to homosexual acts as grounds for divorce; moreover in divorce cases homosexuality, per se, should not preclude the equal right of child custody; 7. the right of homosexuals to serve in the Armed Forces, and therefore the removal of provisions for convicting personnel of conduct and/or acts legal under the Criminal Code; further the recinding of policy statements reflecting on the homosexual;

8. to know if it is a policy of the Royal Canadian Mounted Police to identify homosexuals within any area of governments service and then question them concerning their sexuality and the sexuality of others; and if this is the policy we demand its immediate cessation and destruction of all records so obtained;

9. all legal rights for homosexuals which currently exist for heterosexuals;

10.all public officials and law enforcement agents to employ the full force of their office to bring about changes in the negative attitudes and

on the line at brantford

The small town of Brantford Ontario with a population of about 60,000 seems an unlikely setting for Canadian workers to rally against Amerikan imperialism, yet that seems to be precisely the situation that has been shaping up there.

The Canadian Textile & Chemical Union (CTCU) is engaged in a vicious labour dispute with Texpack Ltd, superficially concerning wages, vacation pay and improved benefits. The 150 striking employees, 85% of which are women with an average take home pay of less than sixtyfive dollars a week are demanding a sixty-five cent an hour increase over a two year period. The company in its final offer saw its way clear to offering twenty cents over the same period. The strike is now in its seventh week.

In actual fact, the company's primary interest lies not in a strike settlement but instead in closing down production in Brantford and using the plant mainly as a warehouse. Over the last nine months the operation has been phased out to the extent that 175 employees have already been dismissed.

Thus the CTCU finds itself in the position of fighting a battle against more unemployment as well as highly exploitive wages. It has no desire to see another example of a foreign owned factory go the route of Dunlop, Acme Screw & Gear, Towne & Yale etc. which all closed down their Ontario operations in the last few months.

Texpach Ltd. was originally a Canadian firm subsidized for expansion twice by the Canadian government in 1965. However in December '65 it was bought out by Pharmaseal Ltd. of California. Following this up, Pharmaseal is in turn owned by the American Hospital Supply Corporation which is almost alone in the field of selling hospital supplies both in Amerika and in Canada. Apparently they sell every hospital need from 'the paint on the wall to the pan under the bed.' American Hospital is also heavily contracted to the pentagon

Let us be clear. We are not fighting a small American firm, we are fighting a giant American corporation with subsiduaries and exploited workers in 120 countries around the world. Their 1969 sales figures totaled almost \$450,000,000 and their sales and profits have been increasing by 15% each vear.

Notwithstanding the relatively small amount of money involved in the dispute, so far, of the 150 striking employees, 10 have been dismissed for strike activity, (contrary to Canada's Labour laws) and sixty women havw been arrested and charged (mostly for watching and besetting, whatever that means). Also an illegal injunction has been brought down against the strikers by Justice T. Moorehouse of the Ontario Supreme court. After the imposition of the injunction, the Brantford police felt justified in increasing the pressure they had already been applying by means of their riot sticks and other assorted gear to the heads and backs of the women. Sound like your typical Jahour disoute?

It goes a little deeper. Before the strike was called, a statement (threat) was issued to the employees explaining that if they were to take strike action they would be permanently replaced. The company then proceeded to boast of the efficiency in strike breaking. Next, vacation pay owed the workers was refused. Advertisements were taken in the Hamilton spectator under a fictitious name recruiting strikebreakers. Also three American owned security agencies (security spelled SCAB) were enlisted to crush a former RCMP officer), Angus Protection and

Investigation Services (owned by ex-FBI "MADE IN CANADA" & "STERILIZED". executive) and SIS services. Three goons (supported by the Brantford Police, OPP and Hamilton Police) from a Driver's Pool are used to drive 140 scabs through the picket line into the plant each day. The use of scabs unions, is primarily a demoralization tactic used by strike smaching organizations. Their productivity rates are on a par with their

On Saturday Sept. 4 a mass rally sponsored by the Waffle Labour Committee of Ontario was held in the Grandview Community Hall in Brantford. The WLC pledged financial and moral support to the workers and condemned the government of Ontario for its illegal injunction. The rally was held to enlist support for the strikers by making people aware of the facts and issues involved and what they mean to Canadian workers:

A) production in Canada is being greatly decreased and the Canadian market flooded with American goods of inferior quality.

B) American investment means loss of Canadian jobs

C) American companies act as if our Labour laws don't even exist and act with contempt towards them,

So far in this strike, the Hospital Supply Corp. has broken labour laws on at least

1) firing strikers

2) hiring scabs

3) illegally obtaining an injunction

Also the Combines Investigation Act has been violated with regards to flase advertizing. Supplies of W.W. 11 army surplus pressure bandages, some dating back to 1942, have been received at the Brantford plant. The workers were instructed to remove the bandages from their original army issue boxes and to reinsert them as they went into boxes reading "SAFECO"

These bandages are primarily distributed on Canadian industrial sites for use on injured workers. This type of stunt has been good for enlisting solidarity with other Canadian

So far the Mill Mine Union and Smelter Workers of Sudbury, Hamilton Steelworkers, and London & Windsor Auto workers have lined up behind the CTCU and its women. Money has been pledged in an effort to support a relatively skimpy strike fund. One woman week strikepay.

Meanwhile public outrage in Brantford concerning the consistent use of police muscle on the women and their supporters seems to have succeeded at least temporarily in having the police called off. On Thursday Sept. 2nd, 1000 people demonstrated in the area of Texpack against the injunction imoosed on the workers. On the same day the police gave notice to the SCABS that they were on their own and would receive no nore police aid. This in itself is a small rictory in the battle.

In order to stop worker exploitation and n order to put giant corporations behind the law and not in front of it, we need a working class solidarity. With such, we would have the power to control our own destinies. The women at Texpack have provided us with a focal point for militant unionism which we must not let slip away. This strike is not a local issue, it is a working class issue and needs the support of such.

A demonstration of support will be held Thursday, Sept. 16 at 4:30 p.m. in Queen's Park to confront the Davis government. This situation must be brought forcibly to public attention. The CTCU will be there, the Sudbury Miners will be there, Waffle will be there, UAW will be there. You be there.

odyssey revisited

Funding has always been a problem for "street" agencies that have worked outside the normal fold. However, because most street agencies have proven their effectiveness over established institutions, they manage to survive.

Odyssey, the referral agency working out of Yorkville is trying to imitate the initiative taken by agencies like 12 Madison, the Hall and Stopover.

In a 12 page proposal, Erna Koffman, Odyssey's director and presiden is attempting to put together a "relevant" agency somewhere in the downtown. This move by Koffman comes after her offices on Yorkville saw little more than 30 people a week this summer.

The proposal is aimed at straight funding sources and politicians in a last desparate attempt to get money as her present grants run out without renewal. In terms that have been described by one youth worker as "simplistic and with moral overtones", the proposal talks of the alternate lifestyle "wiring" young people into a "parasitic, existence. Aiming hard for money, Koffman's report is couched in phrases like "middleaged copouts.., "sub-culture" for counter culture, and descriptions of most of the young population who do not expouse "organized society's" values as "burns, con artists and thieves.

In the proposal, she is expecting funding of \$64,447 from various government sources. The request for funding is based on figures for 1970; during the operating months of 1971, ODyssey has had only about one third of the previous year's traffic according to staff workers.

With the \$64,000 the new "relevant" ODyssey will enter the area now being adequately dealt with by Stopover. The plan is to put together a fifteen person residence, a group therapy program and a drug and problem counselling and referral centre.

However, the proposal by Koffman fails seriously to note the need for increased staff and new staff policies. Similar staff problems have already lead to two major resignations of personnel and a high staff turnover with 10 workers leaving in the past seven months.


Two workers mentioned in the report, quit the organization August 27 because 'things are so bad at ODyssey that the kids don't dare come in." "We found it impossible," said Shelagh "to work at ODyssey with Erna undermining us constantly and interferibg with our relationships with the kids. They don't trust her - are afraid of her and they will only come in when she leaves."

Funk Karls complained that most of the agencies in Toronto have complained about ODyssey under Koffman's administration and that they as workers "have found it almost impossible to work effectively with these agencies because of interference by Koffman" and her attitude of relating to them as "hippie-dippie blue jean organizations."

The resignation of Karls and Graham left ODyssey with only one youth worker, one interim person and Erna Koffman, herself, who is only a registered nurse with a B.A.

The report itself asks for a sum of \$35 per day per person for treatment and operating costs. This would make ODyssey one of the costliest ventures of any social agency in

And according to one major source the proposal is "poorly conceived, unrealistically staffed, and unworkably ambitious."

WACHEEA: GRASS ROOTS

When Grass Roots started putting together the concept and then the reality of Wacheea several months ago, one of the concepts embodied in the design of the park was "community control". We felt optimistically that park residents would determine the direction and content of the park through general meetings, and meetings around the various activities of the park (security, food, medical, etc.). But beyond this vague idea, we had no plans for how community control could be achieved.

From the day we got to the Mercer site, leadership became ad hoc. Reople who were into cleaning did cleaning, people who were into taking charge of things took charge and made sure they were done. By the beginning of August the site was fully ready, and the basic manual labour was complete.

But in the rush to get it on, little had been done to overcome a dependency and authority relationship that was central to the way the park was being run. Grass Roots people were regarded as "authority figures" to be consulted on everything. This attitude denied the people in the park the opportunity to do something most of them had never understood they could do-take charge of their own lives and work collectively with those around them. But the distinction between authority figures and "others" was perpetuated in people's heads. This contradiction led to the result in the park that it also leads to in the capitalist system - revolt.

It is important before going into the chronology of that revolt to understand some of the factors that were leading to the contradiction. One factor, which I think is the most important one, is the class difference between the park "originators" and its residents. Grass Roots people are primarily middle class, and thus capable of relating to financial management systems, endless meetings, bureaucracy, reporters, etc. But the people in the park are fundamentally different; Marx would probably describe them as the lumpen proletariat - street kids - who have left home when they were twelve, lived everywhere, been busted many times and fucked over by prisons, social

workers, and each other for most of their lives. Basically we had planned the park for middle class freaks like ourselves who are freer to choose a co-operative ideal. This ideal became utopian in the face of a population that could only understand individual survival struggles because of their lifelong oppression.

Another factor was a failure of leadership from Grass Roots. After the bust at the U. of T. and the incredible hassle of securing the Mercer site, most of the leadership of Grass Roots were completely exhausted. We escaped to Algonquin Park to salvage our sanity the same week the Mercer site was secured. This dumped an impossible burden on a very few people in Grass Roots, who, of necessity, spent most of their time doing the work of setting up the park rather than allowing a slower development that would more directly involve the people in the park. There was also a failure of leadership on the part of Judy and myself, as "financial administrators" as far as Opportunities for Youth was concerned, to explain what that meant, as well as constantly discuss the monetary situation. People in the park developed misunderstandings about money, thinking we had more money than we really did, had spent money unreasonably, etc., partly because Judy and I had chosen to work out the technicalities of the contract with O.F.Y. on our own, rather than collectively with the people in the park. Even now that the financial committee is established our energies are so low that we do not take the time to explain the basis for financial decisions.

The third factor involved in the "authority figure" contradiction, based somewhat on the two I have already described, is the backgrounds and socialization that people brought with them as baggage from the past when they entered Wacheea.

Street kids are conditioned into a love-hate relationship with authority figures (police, welfare officials, etc.). They are conditioned to "respect" them in a very fucked-up sort of way as the source of any "assistance" - the crumbs of survival. But instinctively, they also hate the authority figures as the most visible and close-at-hand symbol of the system that has oppressed them from the moment they were born. Thus Grass Roots was falsely cast into the uncomfortable role of oppressor.

These three factors, I believe, are essential in understanding the "revolt" that developed. Judy and I had gone to Ottawa to re-negotiate the contract with Opportunities for Youth, securing slightly more money for expenses which was more in line with the operations of the park.

When we returned to Toronto on August 16th, people in the park ordered us to attend a general meeting. As soon as we arrived, we were told that if we didn't turn over ocntrol of the finances, we wouldn't leave the park alive. Although this was pretty heavy, it made us realize that park people were beginning to assume control of running Wacheea (the way we had hoped they would for quite some time) and now were demanding control of the only aspect of the park they did not yet control - fianances. Accusations of ripping-off money, inadequate food, and lack of participation of Grass Roots people were leveled at us. People wanted Grass Roots out of the park.

Out of the shouting match, and an explanation on our part about the financial situation, a compromise was established; Grass Roots would work with a finance committee, elected out of people in the park, whicy would make all financial decisions and review spending up to that point. Since then, the finance committee has made all financial decisions, with Judy and I being cast in the role of bankers. The finance committee "withdraws" its money from us when they wish; we administer the receipts, see the auditors, and account for the money to Ottawa. People who feel they deserve money see the finance committee, and the decisions of the finance committee can always be appealed to a general meeting of the park. For a brief period of time, this compromise soothed tensions at Wacheea and trust relationships were beginning to develop.

Since Wacheea had been at the Mercer site, there has been another factor affecting the state of the park besides the legitimate grievances of people in the park. As far-fetched as it may sound, there has been an infiltration (since purged) of a very right-wing, brown-shirt element interested in disrupting the park's activities and seizing the park as a recruiting ground for their right-wing group. These individuals are known to be associated with the Canadian Information Service, who seem to see the park as part of the "international communist conspiracy". The tactics of these people have ranged from threats on people's lives to lies concerning the finances of the park. They convinced a few people to go to the Star and Telegram with gross stories of financial wrongdoing. The Telegram, which got the information for the story on approximately August 23rd, refused to print it once they determined its source (strangely responsible journalism for a reactionary paper that has consistently opposed Wacheea).


The Star, however, began manipulating with its story as soon as they got it. On August 27th, the Star reporter who had the story made a deal with Cam Mackie, the Director of Opportunities for Youth, not to print the story until after O.F.Y. had made an investigation. Rob Andras, the Ontario Director of O.F.Y. phoned me on the following Monday to say that they were ordering a full audit of the books in accordance with the deal with the Star. Then the Star whelched on its deal; front page on Tuesday Aug. 31st, was the headline "Ottawa launches probe of Tent City finances". Several leading questions and the whole slant of the story led the reader to believe that Judy and I were guilty of fraud, mismanagement, and many other crimes, and had mislead people in the park. We immediately consulted with our lawyers and are continuing to investigate the possibility of a libel suit against the Star. We also held a resss conference that day to counter the story in the Star, and explained to the bourgeois press how financial decisions were being made in the park, and why the stories in the paper about people being underpaid were untrue. Subsequent stories in the bourgeois press did explain to a certain extent where the confusions had arisen. Moreover, the auditors initial study of the books have found no justification for the Star's concern and sensationalism. It is important to understand, however, that the brown shirt element has been capable of manipulation because of the orientation of most of the people in the park towards their own survival. Even though a system of self-government had been established through the mechanism of the financial committee, individual people with what they thought were legitimate grievances were not interested in struggling through them with the other people in the park; rather, they chose the route of challenging the "authority figures" (i.e., me) they thought were oppressing them. This was divisive, and, has led to a heightening of the tensions in the park as it draws to its closing date on Sept. 9th.

Grass Roots has grown in many directions since the original conception of Wacheea; what that growth means in terms of how we can build from this point can only be determined once the park is closed and the heat of the present dies away.

Time will allow a complete analysis from everyone's perspective on what the lessons of Wacheea have been; class tensions, styles of leadership, effects of government financing, and methods of achieving real community



Since 1966, Ottawa has moved mountains in its youth-seduction campaigns. "Uncle Les" B. Pearson launched the Company of Young Canadians that year. He yielded to a younger man.

But the CYC still fucked up its mission, which was keeping youth in the frying pan of status-quo big business. Its people kept unearthing new things about how and for whom the country is run.

So the fire beneath the pan had to be enflamed. The idea: quell the temptation to leap from the pan. Seduction became rape.

Last year's FLQ terrorisms surprised Prime Minister Trudeau, treating t.v. viewers to his Judas performance, where he betrayed the companions of his youth. Since then the crude War Measures Act has supposedly been replaced. But both the performance and the "replacement" Public Orders Act show fear. And from that moment, nobody's doubted that Trudeau means to get tough with youth.

Meanwhile, back on Parliament Hill (while the straight press bared its editorial teeth at "Trudeau's Travels"), three Government devices zeroed in on young activists. And there was hardly a murmur of editorial dissent.

Bill C-192: "Young Offenders Act"

This Bill is not yet passed by Parliament. But it is well past its 2nd reading. It is being sold by Solicitor-General Pierre Goyer as an enlightened replacement of the Federal "Juvenile Delinquents Act".

Goyer says in effect, "if the Bill becomes law you can't be charged as a juvenile delinquent, regardless of whether you rode an unlicenced bicycle or committed murder; you'll be charged only with the act you've committed, and treated accordingly — you'll have a lawyer and a formal trial."

Sheer bull. It's no nicer being a "young offender" than a "juvenile delinquent". It's much, much worse. How would you like to have the Criminal Code thrown at you when you're 10? This Act clearly aims to make young people — even below the age of 16 — criminally responsible for their actions.

It is also aimed at putting a fence around youth. Consider:

Section 57 (1): Except to the extent that they are inconsistent with this Act, all the provisions of the Criminal Code relating to summary convictions offences, apply to proceedings under this Act . . .

Few if any lawyers have found any "inconsistencies" worth mentioning.

The Young Offenders Act (now called

Bill C-192 because not yet enacted) is weirdly vague on the multifarious "summary conviction offences" from the Criminal Code. These are destined for insemination into the "Young Offenders Act". But consider that the Criminal Code includes "inciting to riot", "acts of subversion and espionage", etc., and you have a de-escalation of Government terror against its critics. Why

This Bill provides for arrest without warrant. Under section 7, "No person shall arrest a young person without warrant... unless in his opinion it is in the best interest of the young person that he be arrested immediately."

Hmmm. How about that for "protection"? You'll get it under this Act 'til age 18. Even adults are spared such protection.

Several sections of the Bill permit a person under 16 to acquire a criminal record. Naturally, his fingerprints and mugshot are funneled to the RCMP. Anybody over nine years of age may qualify.

Best of all: Section 30 (1) (k) allows a young person to reappear before a court at 21 – because of something he did while a juvenile – "to be sentenced as though he had then and there been convicted of the offence that he was found to have committed and as if he were thereupon liable to imprisonment for life."

Pretty heavy trip for an "improved" Act. A number of straight organisations, Children's Aid Societies, Canadian Mental Health Association, Canadian Correction Society, etc., have protested against this Bill. A New "Secret Security Force"

Toronto Telegram, Ottawa, Aug. 27. "The creation of a secret Government civilian security agency was revealed yesterday in Government documents recruiting for the organisation."

"Each analyst is to be responsible for analysis of basic security problems caused by social unrest, subversion and sabotage." His duties will include:

Research into subversive doctrines, use of violence in society, information techniques — particularly the exploitation of the media in the region delegated to him as it applies to various subversive groups assigned to him as areas of prime interest.

The Telegram reporter comments that this is clearly aimed at "further spearatist violence in Quebec or to curb youth riots." (my emphasis both times).

We've known of the media's exploitation of youth for a long time. But this is the first we heard of it working the other way!

If this plan works out — and they're currently advertising for staff — just think: we'll all have our own gauleiter!

The Final Shit

We're going to be shovelled under by the benign, empathetic, scrambled, screwy report of the \$500,000 study of youth commissioned by Secretary of State Gerard Pelletier.

The predictable crap about abolishing cadets and legalising pot is all there... and it's also nice for youth to travel, too. After all, at our first meeting didn't Trudeau lament the inability of every Canadian to go to Greece?

The Government disclaimer on p. 1 was quite unnecessary. Nothing in the report could gain the support of the Canadian people enough to challenge anything.

But it does show that Ottawa is thinking about youth. At this rate, pretty soon they could paraphrase Goebbels, "whenever I hear the word youth... I reach for my gun."

W. Khurshed wrote the following article on Bangla Desh. His name given here is really a pseudonym because he is a member of the Bangla Desh Association of Canada and, as such, would be subject to various forms of discrimination by those members of the Pakistani community in Canada who are still loyal to Yahya Khan.

Khurshed is a native of East Bengal (East Pakistan) who visited China for about three months in 1959 before studying in Japan (1961-67). He returned to East Pakistan briefly, and then came to Canada. Since that time he has visited East Bengal at least once every year.

Interviewed by Guerilla, Khurshed cleared up two major questions - Chinese policy towards Bengla Desh and the relationship of India's furthest east state, Assam, to Bengla Desh

Chou En Lai Khurshed claims, is a Stalinist reactionary. Chou has been on the Central Committee of the Chinese Communist Party since before 1923 when Mai Tse Tung joined the party.

Mao thus has never had the absolute authority many western intellectuals have thought. Thus Chou was able to win, during the mid '60's, a power sturggle with Mao, and later again - at least temporarily, - with both Mao Tse Tung and Lin Piao. Lin has been chosen to become party chairman when Mao steps down.

Khurshed also claims that Chou ruthlessly crushed a lot of militant Red Guards when they began to attack him and he replaced them with more conservative young people.

It would appear then, that since Chou En Lai has dominated the Chinese party for so long, the next few years are going to see many profound changes within the Chinese Communist Party hierarchy as well as in China's foreign

Lin Piao, Khurshed fells, is much further left than Chou En Lai who actually came from well-to-do parents.

Assam is part of Bangla Desh and, up until 1918, East and West Bengal and Assam were all part of the same state. Thus all territory bounded by Western Bihar State and a line just east of the Hoogly River (flowing through Calcutta), the Bay of Bengal, Burma and China is Bangla Desh (Bengal Nation). All people in this area have vastly similar cultures

Khurshed told Guerilla that Ahmed Tajuddin, the leader of the provisional government, has moved, and that the provisional government is now located in Assam. There is a separatist organisation in Assam claled Aham Shadhinata Shangram which has favoured the establishment of an independent Bangla Desh for years.

He described Tajuddin, formerly the deputy leader of the Awami League as "a moderate Marxist."

According to Khurshed, the provisional government is negotiating with the Mukti Bahini (described later) so that they may be included in the government. They are led by Maulana Bhasani, an Assami.

Khurshed tells us that the Awami League, up until March, was essentially a liberal bourgeois organisation. For this reason, Khurshed, himself a Marxist, hopes that India will not declare war on Pakistan because then Indira Gandhi would work to ensure that the old Awami League (now pretty well decimated), or some other capitalist group, - communism.

The ruthless exploitation of Bangla Desh (formerly East Pakistan) for the last 24 years by the West Pakistan bourgeoisie and immigrant Moslem capitalist classes from India, has set the stage for a bourgeois revolution there. Since the formation of the very unusual state of Pakistan on August 14, 1947, East Bengal's Musiums (forcibly converted) had derived no benefit from the association other than the limited but vague sense of security of the Hindu landlords.

All the people of Canada and the U.S. probably know that the subordination of Bangla Desh's economy had been accomplished by the overwhelming concentration of Governmental authority in the hands of the West Pakistanis, namely by the following means:

- 1. Controlling of tariff;
- 2. Import control;
- 3. Industrial licencing;
- 4. Foreign aid budgeting;
- 5. Investment allocation.

Deprived of everything, the bourgeois leadership of Bangla Desh sought to gain some state control through democratic means. Thus it tried to elevate Bangla Desh's status from a colony to equal partnership as called for by the "Lahore Resolution," (the basis on which Pakistan was created). The Awami League under Sheik Mujib fought the only election waged on the platform of autonomy - not independence - in the history of Pakistan and won 167 of the 169 seats in East Pakistan. It became, thereby, a clear majority of the National Assembly of all of Pakistan. Afraid of losing the privilege they used to get in exploiting the colony of East Pakistan, the West Pakistan Militia acted against the people of Bangle Desh under General Yahya



Khan's order, the Militia was to crush the so-called rebellion – a rebellion forced upon the people and which is making a radical turn towards proletarian socialist revolution. This will definitely affect the revolutionary mass in South Asia.

The election was held on December 20, 1970. The seating of the National Assembly was adjourned twice and Yahya Khan cunningly brought the army from W. Pakistan under deceitful negotiation. On March 25, 1971, he sneaked out of Bangla Desh with Zulfikar Ali Bhootto, the capitalist leader of West Pakistan. Bhootto, a typical bourgeois, a former foreign minister, a staunch anti-Indian and an autocrat, got the Chinese support in his hypocritical power politics. On arriving the same night in Karachi, Yahya, military dictator of Pakistan, ordered General Tikka Khan to crush the rebellion.

This crime was committed by Yahya Khan in consultation with Bhootto, Tikka Khan and others.

The militia of West Pakistan started indiscriminately killing the masses on the night of March 25, using the full military machinery. Within a week over 300,000 were brutally slaughtered. After the initial setback, the resistance force was formed, from among the leftist parties, including some Maoists. The Awami League leftwingers were allowed to form the provisional government under Tajuddin Ahmed, a moderate Marxist. The venerable 80 year-old peasant and Marxist (pro-Peking) leader, Maulania Bhasani, formed the six leftist parties' united front. He is leading the liberation force, named "Mukti Bahani," dedicated to the Socialist Revolution.

China's role in Bangla Desh's struggle has put the world revolutionary mass in utter confusion, so this should be explained, with the background of some Chinese, Pakistani and Indian leaders.

China's present leadership supported the need for a separate independent socialist Bengla until the Sino-Indian border conflict. Up to the border clash in the Himalayas between China and India, they were partners of the five principles of neutrality between the Soviet and Western blocs. The adamant attitude of both parties against a common demarcated border led to the border war, during which the autocratic West Pakistani military leaders persuaded China to make a common alliance against India.

Chou En Lai, the shrewd Prime Minister of China, accepted the hypocritical West Pakistani offer against all the commitments the Chinese made to the Bengali. Some Chinese leaders had shown their utter disapproval of Chou's acceptance of the offer by Pakistani military rulers. Field Marshal Ayub Khan, then the dictator of Pakistan, failed to see Chairman Mao Tse Tung on his Chinese tour. Lin Piao once condemned the Pakistani policy in Vietnam when Governor Money Khan visited Chine in 1966.

Analysis of the facts proves that the present policy of China regarding the revolutionary struggle is Premier Chou En Lai's policy. It proves Chou has won the power struggle in the Chinese hierarchy. Mao has been set aside, regarding foreign policy, at least.

Yahya Khan succeeded Field Marshal Ayub Khan in 1969 when the mass uprising in Bangla Desh forced him to step down. Yahya then promised a fair and free election within three months; instead it took place after a year. He made it quite clear that he had no political military ambition, but swerved from this after the results of the election of December, 1970.

He collaborated with Bhootto and together they moved the army into Bangla Desh and denied the elected members the right to form a government. Yahya, being a dictator, followed a bit more sophisticatedly than his predecessor in the first few months. But it wasn't long after, that he started to secretly scheme the most treacherous and reactionary policy of crushing any form of democracy and progressive ideology.

He denied any kind of help to the cyclone-affected people. He even sent back that which had arrived from foreign countries to the devastated areas. This he did after more than one million had died from these floods. At that time – 1970 – Bhootto was placing more importance on a Grand Prix and treating their disaster – the worst in 500 years – as a casual natural calamity.

So, the West Pakistani military capitalist rulers showed they were planning to eradicate the whole nation of Bangla Desh by any means. If a natural calamity could further their plans, let it happen.

Hence a section of Chinese leadership, by choosing to render support to the "Yahya-Bhootto Company" is taking a counter-revolutionary and reactionary policy. The Chinese policy is in utter violation of Marxism and Leninism. This proves that a section of the Chinese presently are not behind the great proletarian revolutionary struggle of Bangla Desh, which might open the way for a world revolution.

Another cardinal point is that the U.S. administration also gives full support to the reactionary, dictatorial, colonial and autocratic rulers of West Pakistan.

To a certain extent they are acting under a co-ordinated plan. This hypothesis obvious to anyone following developments since March 25 – eg. the "Kissinger Dash" to Peking and the forthcoming Nixon tour to China. The U.S. has accellerated her arms supply to the notorious regime at a very high rate. There are 200 U.S. personnel working in the West Pakistani defence; 300 Americans are working for the reactionary government's intelligence – acting as members of the U.N. observers team for the refugees. It is worth noting that the above-mentioned persons are C.I.A. agents,

as complained by the resistance forces in Bangla Desh and by a section of the people of the U.S. who are supporting the struggle.

The U.S. authority has not denied this at any time, officially or unofficially.

Let me explain briefly how the success of the revolution will affect the course of the revolution in India, Burma, Nepal and the Middle East. The states of West Bengal and Assam of India will be immediately drawn towards the struggle of socialist revolution as culturally, ethnically and liguistically the people are the same as those of East Bengal. As soon as this section of India is engulfed by the revolutionary struggle, the rest of India, Pakistan and Afghanistan will be affected and the struggle in Burma will be pushed towards great success. Thus Thailand and Malaysia will get the transfusion of the revolution. From the border of Laos to the Middle East, the Bangla Desh struggle will be the centre of guidance and inspiration. It may well become the dynamic moving force of the socialist revolution.

This struggle is similar to that now taking place in Ireland. The Irish Republican Army has already sent personnel to support the revolution.

Religion plays the most important part in the counterrevolutionary role in Southern Asia. The Bangla Desh struggle will deal a death blow to the reactionary religious nolitical struggle.

In West Bengal, as in Bangla Desh, each Naxalite (Communist) group represents a leadership in Peking. All groups, with the exception of the Toha-Chattarjee are actively participating in the revolutionary struggle of Bangla Desh.

Canada's policy regarding this heroic struggle is a mixture of intentional ignorance and antipathy on the part of the bourgeois class and the government.

I interviewed 20 workers near where I work. I found five of them offering voluntary service in the struggle for peace in Bengla Desh. Ten of them promised all kinds of help if needed. The remaining five have shown sympathy. But, one of the bosses of the same company had shown real antipathy and identified the Bangla Desh struggle as a kind of gangsterism.

The only other group which supports the Yahya regime is the so-called Maoists. These Maoists are a kind of mouthpiece for a revisionist group of the Peking Government. They represent Chou's claque, bureaucratic, and bourgeois oriented. They do not represent the real leadership of China and the Chinese people.

In this article, I have tried to draw an outline of the revolutionary struggle of the people of Bangla Desh; a struggle of national liberation and a socialist revolution for a classless society where there will be no place for exploiters.

Bear's Lair

Douglas Upton's private little war with the Ontario Housing Corporation has escalated another step. The 32-year-old precious metals worker is defying orders to vacate his maisonette at Scarlettwood Court and plans to take his case to the courts.

It all began last November when Mr. Upton's union, of which he is local president, went on strike. Since OHC rents are geared to income, Mr. Upton unilaterally reduced his own rent from \$124 to \$28. Not surprisingly, OHC objected.

OHC managing director Paul Goyette pointed out that the corporation cannot take sides in a labour dispute. By reducing strikers' rent, OHC would be placing its own weight on the side of labour in industrial conflicts. In any case, the OHC, an agency of the province, cannot very well deviate from the official Government line which does not recognize strikers as being unemployed.

This, however, is not a line of argument that Mr. Upton and the Ontario Housing Tenants Association find very reasonable. They note the OHC lowers rents when a tenant is locked out by his employer; why not when he is on strike? Because, replies OHC, the worker chooses to go on strike, he does not choose to be locked out. (And, in any case, aiding a locked-out worker does not benefit the employer.) "The OHC is strictly against strikers," retorts

He should know better. Mr. Upton is, after all, a union official. In addition to being president of his shop local, he is also president of the Toronto and District Joint Council of the Canadian Labour Council. Surely with this kind of labour experience, he, of all people, does not need a lesson in the mechanics of industrial disputes.

A strike is the final battle in an economic confrontation between workers and management. As such, the Government can take no part in tipping the scales one way or the other. Just as it must steadfastly refrain from jumping in to assist management during a strike, it must do the same for labour

If the OHC were to subsidize tenants who went on strike, then management would have a fair claim to similar subsidies. If Mr. Upton wants the public to pay the costs of his strike, why should Mr. Upton's employers not be entitled to some form of public help in reducing their taxes or underwriting lost profits?

And what would the situation be if an OHC tenant, employed by a Government agency, went on strike? On the one hand, the tenant would be attempting to exert some economic pressure of the Government while, at the same time, quietly claiming Government help in that struggle.

The Housing Corporation has no business meddling in Labor-Management disputes and It's a pity that Mr. Upton seems incapable of accepting that fact.

LIBERATING

I'm rapping with cartoonist Dan O'Neill and we're in the studio of the Air Pirates located in the subterranean depths of San Francisco. All around me are black and white drawings of the characters that invaded my consciousness as a boy through Walt Disney's Comics and Stories, the Big Little Books, and hundreds of animated cartoons about funny ducks, dogs, and mice. As we talk, O'Neill, now 29, longhaired and ageless, graphic anarchist outlaw, shows me drawings. Some are from his Silly Sympathies, a part of Mickey Mouse Meets the Air Pirates Funnies, others from a new 52 page comic book soon to be published by the Glide Foundation.

I first turned on to O'Neill when his *Odd Bodkins* strips appeared on the comic page of the *San Francisco Chronicle* in the mid-sixties. The strip ended recently when Dan's strip about the Marin Country Courthouse shoot-out was censored. *Odd Bodkins* existed in the realm between politics and metaphysics. It was a strip that bridged the gap between hip and straight readers and, shortly before it ended, it was infiltrated by a number of old Disney characters who, according to O'Neill, were no longer under copyright. When they ran in *Odd Bodkins*, they were copyrighted by the *Chronicle* and by O'Neill personally. At this writing, O'Neill claims to have copyrights on over 200 characters.

Disney comics claim distribution in 118 countries and 36 languages. "All of the people in those countries have had an image inflicted upon them," says O'Neill. This is serious, because that image has slowly become an adjective and the adjective is close to becoming myth. Not long ago, Mickey Mouse appeared on "cover of *Life* magazine. People talk about him as though he were a real person. Everybody knows what "Aickey Mouse means, and it's dangerous to have your country represented by an adjective." As far as O'N. is concerned, "Disney taught the world how to look and listen, then he copped out and didn't say anything."


Every high school and college student knows what a "Mickey Mouse" course is, and by extension, the course is given, not only in America, but in 118 other countries as well.

"The only book that sells as well as Mickey Mouse is The Bible. Drawing the characters is like taking Genesis. We are Disney, good Disney, and the point is that we are doing it well, while the artists who are grinding it out for Disney's empire these days are doing it badly."

"Mickey Mouse sits in everybody's brain. It was put there by somebody else. I didn't ask for it. Walt Disney is a tresspasser. He's not even original. He's ripped off American mythology right and left, stealing characters from Washington Irving and Mark Twain. He stole archy and mehitabel from Don Marquis."

Before someone comes along and accuses O'Neill or any other artist of ripping off Disney's characters one must ask just which characters belong to Disney and which ones are under copyright. Recent suits have been filed by Disney lawyers "to protect the Disney image," most of them underground posters and satirical art. A suit about Joel Beck's Daisy Duck poster some years back fell through because Disney's Daisy had no teats. Joel put a pair on his modern Daisy. Beck was into Disney Liberation as early as 1968 when he did "Mickey Mouse Today" in the first issue of Yellow Dog. O'Neill's Mickey has a little something





Walt's mouse never had, too, which means some interesting courtroom theatre if it ever comes to that.

Joel Beck was updating Mickey and the Air Pirates are not into that. The studio is out to liberate all of Disney's characters and to destroy the Disney empire. They are working with period Disney, the characters as they were drawn in the late thirties and forties. Air Pirates is not even a group. It's a game, a philosophy. Says O'Neill, "We're on an acid trip, slowly eating through everything that hasn't got wax on it. We're outraged at what Disney has done to our heads and right now we're getting it all out. Disney is our springboard and we're suing him as a jumping off point to get us into some serious drawing. This is our last defense against schizophrenia."

Dan O'Neill's association with The Committee, an improvisational theatre in North Beach, got him interested in drama. The Committee improvises on social and cultural themes and organizes an evening program of the improvisations which prove effective. O'Neill talked to some other artists and got together a small group of people to jam some comic stories for the first issue of *Mickey Mouse Meets the Air Pirates Funnies* which hit the stands in July of 1971. In the sessions, the artists became the characters they were drawing. They act out the stories about the Phantom Blot and Mickey Mouse and Zeke Wolf and sit down afterwards to draw them. To do his strip, *Dirty Duck*, Bobby London studied and learned the style used by Harriman to do *Krazy Kat* in the twenties. For *Silly Sympathies*, O'Neill, Ted Richards (creator of Dopin' Dan), London, and Gary Hallgren learned the style of the Disney comics of the thirties. For the second issue of *Air Pirate Funnies*, three women have joined the studio: Cartoonist Michele Brand, whose stories appeared in *It Ain't Me Babe Comics* (July, 1971); Shary Flenniken, and Terre Hallgren.

The young cartoonists now in the studio intend to reverse the Disney morality, to clean up the ugly, disguised, anti-life world that has been plugged into their (and our) heads through the comic book medium. The comic itself is printed with a *Hell* logo (as the Disneys used to carry *A Dell Comic* and the covers are slightly altered versions of the covers of Big Little Books. Where the comics are printed is not known. Rumor is some basement press in Los Angeles did the work.

What about that Disney morality? Well, as far as I know the only time any of those Disney characters ever got laid was in Wally Wood's Centerfold in Paul Krassner's *The Realist* and I never did see any of them light up a joint or worry about the ecology of the country or consider the socio-economic background of the Beagle Boys and Black

Pete and I know all those ducks were white and middle-class and none were black and on and on. So everybody knows what kind of morality Disney propagandised over the years, but few people have done anything but accept it. In Air Pirate Fiunies, Dirty Duck gets kicked out of an Adult Bookstore by a woman for trying to get some of the staples out of a magazine. A few panels later, he leans out of a window, and says, "Hm! What a fine grade of opium those 6-year olds are smoking out there..." Later on, Annie meets Chuck and Mickey and Chuck asks her: "Hey — y'wanno go smoke some dope and drink some wine?" Annie, knapsack on her shoulder, answers, "Sher." O'Neill in Silly Sympathies starts out with Bucky Bug telling the reader, "I ain't touched a woman in fourteen years."

WALT DISNEY

O'Neill's most outrageious parody is Lorna Jean, a caterpillar with fifty clits. Bucky has to satisfy her.

Ted Richard's Dopin' Dan takes off on the Army strips, but the dialogue between the sarge and the private is nothing like that in *Beetle Bailey*, Says the Sarge, "This is the *Third* Goddamn lid I've found in yer locker this week!" Dan and the Sarge turn on and wind up in the stockade.

Outside of the comic, the Disney Liberation Front has plans for more spectacular actions against the Anaheim empire. O'Neill and Krassner, with some of the other Air Pirates, have put together a radio show for KSFX-FM and Krassner is due to publish O'Neill's "The Phantom Blot Hostility Report" in the next issue of *The Realist*. O'Neill said that Krassner was the only man ever to get a dog inside of Disneyland and the dog freaked out because he was the first. The reason he freaked was that there was no urine trail on the trees. So there are now plans to infiltrate Disneyland with bags of urine to make the trees. After that, hundreds of stray dogs released in the parking lot and . . . The whole idea is based upon the anal hang-ups of Disney-

The whole idea is based upon the anal hang-ups of Disneyland. It must be the only amusement park in the world with a special department made up of horseshit-sweepers in clean white coats.

With outlaws like these air pirates around, we may yet see the day when Pluto raises his hind leg like a normal dog while Mickey Mouse scratches his fur for a flea.





The Piper - Payer

It's not true that commercials will soon take over T.V. In fact, they *took* it over years ago in North America. Last week I sketched their baleful influence on what you see.

Advertisers have grasped this kind of clout because they pay the freight. And in our "free-enterprise" fortress, you know what that means. Right: they run the good ship video, to mix a metaphor.

NETWORKS are afraid of sponsors. PRODUCERS are afraid of sponsors. Eric Sevareid is afraid of sponsors. (He merely masks it well...and this is known to T.V. journalists as "professionalism". Even Government is afraid of sponsors. Otherwise, how to excuse the asskissing timidity of the CRTC and the American FCC?

Apart from butchering our entertainment and news,

SPONSORS lay another heavy trip on us. The commercial.

All Together Now: "Air Ca-na-da, Canada Tells You What. . ."

The media mafia today is a brotherhood of the SPONSOR and the AD AGENCY. Together they've grabbed from 4 to 10 minutes of every hour of t.v. that you see. What are they doing with the time they've pre-empted?

They're selling. The old capitalist dream of possession via exploitation is now live, in colour, with persuasive voice and lyric song. Do you need examples?:

CP... spanning the nation with telecommunications, letting a Vancouver pig radio anti-protest data to a Toronto pig in seconds. What does this dream add up to? Instant technology = instant power.

Eastern . . . "The Wings of Man". And the dream? Flying expensively excommunicates you from the masses, and their grubby, mundane whining. (Also allowing the secret thought: who cares if they live in bitter, poor hopelessness? They deserve it, don't they?)

Mars Bars... Nancy Greene Raine eats 'em. Dream on, sucker: the caramel carves up your teeth and the chemical additives rake over your stomach. But so what? Charisma, charm and athletic invincibility wait right around the

Three kinds of exploitation. There's at least three more, but let's take these first, one by one.

The Power Trip

A man or woman hates the job. Never corrals enough pay to buy needed or desired things. Barred from anything beyond minimal pleasures. Hemmed in by society's rules.

Solutions: Socialist security, educational chances, revamping the laws. But how about this? Deceive him to feeling he's on top of the system. Flatter his yearnings: give him the expertise of Werner von Braun, the authority of the Pope, the freedom of choice of Papa Doc Duvalier.

How to make these deceptions work? Simple: a commercial. CP's technology is for you, my good man. Telex our friends, buy fresh fruit via our piggyback fridge cars. Or holiday in one of our luxury hotels. We're doing this for you, dear sir. Naturally we clear a slight profit. But you're a part of us, so it all funnels back to you.

Hit a man with this spiel 8 times every Argo game, 12 times each hockey game, 12 times for each "Wide World of Sports". The dream of something really better flickers up the antenna, and dies.

The man and woman clutches the delusion of power. He or she changes into a consumer. But a mere consumer holds no power. A consumer can only . . . consume.



The Id Pimp

OP' ti-mist, noun. 1. A person holding the doctrine that reality is essentially good. 2. A person inclined to anticipate the best or a better possible outcome.

The optomist lives in the id, if you dig Freud. Since infancy, it has fattened on the fantasies of the race. It wants dreams to be born, it wants desires to burgeon

Finally it is ground down. Then it knows only that

dreams are for, and from, the elite few.

Enter Eastern Airlines and its ad agency. The theme "Zaratheustra". The jet into the sunset shaving the clouds which fall to the sea in whitecaps. The earthbound elegant symbol of man's greatest quest, the leap into space.
"The Wings of Man." Or if you will, the whores of

profit. Several airlines go where Eastern goes. But only Eastern nurtures the optimist of the id. For its commercial says: fly with us - be Orville Wright above the dunes of Kitty Hawk, or Charles Lindberg piercing the fog of France. Or, if you want it badly enough, Colonel Glenn, ground control will give you "all systems go" . . . and you may go. Nobody fully understands these incoherent dreams. As I

vrite about them now, even I feel their urgency. What chance then for most of us to avoid this advertising scheme which reaches down below our level?

And more importantly, what chance for us to understand that these desires are NOT for and from an elite few? If we channel them towards the kind of society where we are really free to dream, we channel them to the realities of our life. And we end the exploitation of these realities for the ole benefit of a few.

The optimist is not at fault. The fault stands with the oppression-oriented groups who would pervert the optimist for their own profit.

Machismo, Bobby Hull, etc. . .

Everyone loves a candy bar. Nancy Greene Raine happens to love a Mars candy bar. Nancy Greene Raine is winsome. She is a great skiler, her will to win roars over every barrier. She has two beautiful children. Wherever she goes, she makes us proud of being Canadians.

What you've just read is unadorned, thoroughbred *hype* But for two reasons you should read it and understand it. First, it may be hype – but it's "approved" hype. All the statements are either true, or believed to be true.

Second and more importantly, those statements are probably the very thoughts that fled through the heads of the Mars bar people and their ad agency.

And what does *this* type of commercial exploit? Oh, nothing serious — only the North American obsession with the athletic champion, the ideal mother, the indomitable woman, the beautiful Canadian.

Hero-worship. The Mars bar can't turn you into a hero. It can't turn *anybody* into a hero – except possibly the advertising account exec who thought up the concept behind the commercial.

Why then have Mars bars sales in Canada shot upwards? Because even though we see through this ghastly snow job, we don't think it immoral to collaborate. After all, the Mars bar people aren't Nazis. They don't have concentration camps.

Is that so? Have you ever known a factory worker who was really happy? Who was really satisfied with his or her splinter of life? Who did not look forward to retirement...an end to the crunching chaos of the assembly line?

Now, in what sort of a place do you think Mars bars are made? Seven letters — begins with "f", ends with "y".

Barnum + Population Explosion = 2.4 Suckers Born Each Minute

I mentioned other kinds of exploitation in commercials. Let me run through them quickly.

** Beauty. Beauty products are designed to make

women look as beautiful as they'd like to look. A built-in criticism here — to use a beauty product, you have to feel ugly or inadequate in some fashion. Problem for the AD AGENCY and SPONSOR: how to gloss over this fact.

I personally think it's a pretty good rule, since it tends to guarantee that a dialogue of ideas will take place among the staff and also, it refutes the idea that anyone on the staff should have a privileged position vis-a-vis opinions expressed.

At any rate, if some of you are wondering where my

column was last week, that's what happened to it.

The discussion of the column at the general meeting last night revealed several things to me. First, I wasn't aware that my column set me up in the eyes of newcomers to the paper as the editor - hence the italicized disclaimer which will run at the head of every column from now on.


Secondly, it would appear that few people are opposed to me expressing minority opinion in this space but quite a few are opposed to the tone of the columns. It was pointed out that I don't write the way I talk, eg., I write, at times, if I felt I had the answers. Let me state here and now that I don't think anyone has all the answers. For myself, I work on the probability theory: if I have to act, I act upon opinion which appears, in the light of my experiences, to have the greatest probability of being factual. The idea behind the expertise tone of some of my columns was to jolt people into doing their own thinking on some of these matters. It also tends to get away from the wishy-washy "objectivity" of straight media articles, which end up obscuring the feelings of the writer and aiding him or her to avoid getting at the root of their biases. In the future I probably won't be much more objective, but I will attempt to put down more of my related personal experiences as a

springboard to discussion and learning.

Thirdly, the question of privilege. It was decided at the meeting last night (Sept. 2) that we would introduce a new column in which individual members of the staff could put forth their own opinions on contentious issues. This column cannot be held from the paper no matter what stance it takes. Watch for it, it should be a dandy.

Fourthly, the question of whether this column is worth

the hassle. It was decided by a vote of 19-1 at the meeting that it was, but that merely reflects the opinion of the staff, most of whom are my friends. I've had verbal feedback from the readers, mostly favourable, but that too susceptible to bias. I would welcome letters to the editor expressing opinions on the column one way or the other so that I can get an idea of whether my talents could be used more valuably in some other position on the paper.

And now, having said all that, I'll give a synopsis of the column which got cut. The gist of what I said was that I was concerned for the life-line of free speech here at Guerilla in light of our recent attempts to find philosophical guidelines by which to judge the inclusion of copy in the paper. For instance, The Freak Brothers has been cut on the grounds that it was sexist and could be replaced by a Canadian strip (Harold Head) which was just as good.

The exclusion of material on the grounds that its content doesn't fit the consensus view assumes, I think, that the majority is always right. I'm sorry, but I just don't happen to think that the alternate culture is well enough established (if at all) to ignore contrary opinion. I hope that it never gets that well established. I don't want to work for an establishment.

In the specific case of the Freak Brothers, I think we could well afford to run both the Freak Brothers and Harold Hedd, as well as a strip written and drawn by a woman who considered the Freak Brothers to be sexist. I wouldn't expect Gilbert Shelton to compose a strip which would be an accurate reflection of women's lib sentiment, since he is a man, but I don't consider his work a put-down of women. It's not a build-up of women, either, since it largely ignores them. I feel that that particular job should be done by a woman and Shelton should be left to go on saying the things he is saying about the drug/youth culture in general.
