Shift from Right Strategy 1947 (p.25) ouster of Fr & Ital. CPs
from cabinets of their countries &
rejection of Marshall Plan by Rus. &
forming of Cominform

Non-Maoist strategy accepted in Moscow 1949 June. Pravda
on June 7. 8. 49 published foremost Ch. CP theoretician, Liu
Shi-chi's "Int.-ism & Nat.-ism."

Meetings of USSR Academy of Sciences, on June '47 heralded abandonment
both of right and left strategies, June 1949 indicated
complete adoption of Maoist strategy & on Nov. 12-23, 1951 had
conf. "On the Character & Attributes of People's Democracy
in Countries of the Orient" at Institute for Oriental Studies;
as usual, E.M. Zhukov delivered that chief report.

p.194: Until Stalin's death there appeared differences bet.
Peking & Moscow on degree of originality attributed
to Maoist strategy. While Stalin wanted united front
from above with such bourgeois movements as Kuomintang
or Indian Congress, Chinese advocated united front
with bourgeois from below, incl. parts of the
bourgeoisie against such movements.

"We must by no means allow a recurrence of such
ultra-left, erroneous policies as were adopted toward
the petty & middle bourgeoisie by our party in the per. fr. '31
to '34 (the advocacy of uneconomically high standards in
wkg. conditions; excessively high income-tax rates;... the
shortsighted, one-sided view of the so-called welfare of
the toilers instead of making OUR OBJECTIVE THE DEV. OF PROD.
the prosperity of our economy, the taking into acct. of both
public & pvt. interests & benefits of both labor. and capital)."

"Our policy is to rely on the poor peasants & maintain a stable
alliance with the middle peasants in order to destroy the
system of feudal & semi-feudal exploitation by the landlord
class & the old type of rich peasants. The land and properties
which the landlords & rich peasants receive must not exceed
those which the mass of peasants get. But neither should
be a repetition of the ultra-left, erroneous policy carried
out bet. '31 & '34, the so-called policy of 'distribute no land
to the landlords & poor land to the rich peasants.' It
they do not agree, concessions should be made to them...."
