MANAGEMENT COMMITTEE & MEMBERS OF THE EXECUTIVE

THE ONTARIO HOUSING COPROATION AND THE RPCIA HAVE SELECTED THEIR REPRESENTATIVES FOR THE TENANT MANAGEMENT BOARD. THOSE REPRESENTING THE RPCIA ARE BEV. STEWARD AND NEIL TANNER FROM NORTH REGENT, BOB WOODGATE AND HENRY FRANCIS FROM SOUTH REGENT. O.H.C. REPRESENTATIVES ARE J. DARCY, DISTRICT MANAGER, M. BLACK SENIOR AREA SUPERVISOR, SOUTH REGENT PARK, M. MALONEY, SENIOR AREA SUPERVISOR, NORTH REGENT PARK AND SONYA STOYKO, COMMUNITY RELATIONS OFFICER. THE COMMITTEE WILL BE MEETING AT LEAST ONCE A MONTH AND WILL BE CHAIRED BY MR. DARCY. THE RESPONSIBILITIES OF THE COMMITTEE ARE:

- (a) to review and make recommendation on all individual cases of rent default in Regent Park before formal action has been taken by the Corporation; and subject to the approval of the individual tenant concerned. The tenant shall have the right to appear before the Committee and have a spokesman present.

(b) to review and make recommendations on cases of anti-social behaviour. These cases to be referred to the Committee by the Corporation, the Association or by individual tenant(s). The individual or group making the complaint may appear before the Committee at the discretion of the Committee. The tenant against whom the complaint has been made shall have the right to appear before the committee if he/she indicated agreement in writing to have the case discussed by the Committee.

(c) to review all approved transfers and cases where transfers have been denied or delayed for more than three (3) months consulting the criteria for transfers (point system) which shall be made available to the committee by the Corporation.

(d) to review and made decisions and recommendations concerning tenants complaints which the tenant or Unit Representative are unable to solve.

(e) to review and make decisions and recommendations concerning complaints in general including maintenance items if these have not been resolved through other channels

(f) to review and make recommendations concerning security which have not been resolved through other channels

(g) to review and make recommendations on district budget proposals - relating to maintenance and improvement items for Regent Park.



SENIOR CITIZEN FIRST TO BUY NEW MEMBERSHIP TO R.P.C.I.A.

Mr. C.E. Watson, a Senior Citizen who lives at 41 Oak Street is the first tenant in Regent Park to join the RPCIA. According to the new constitution which was passed at the June 18 meeting, all tenants who wish to participate in the Association and have voting privileges will have to join. Price of membership is 50 cents. Unit Reps will be canvassing for members.

In announcing the O.H.C. representatives Mr. Darcy, stated: "I can only say at this time that my staff and myself would like to relay our congratulations to the tenants of Regent Park on the signing of this new contract and I can assure you we look forward to working once again with your Association in what has been said many times in the past, "another first for the tenants of Regent Park". I am sure this committee will assist both tenants and management in resolving mutual problems. The Management Advisory Contract has now been signed and finalized with O.H.C. and the first cheque presented to the Tenants Association by our M.P. Margaret Scrivener at 101 Bloor with Representatives from O.H.C. - R.P.C.I.A. Executives and the Management Advisory Committee present.

This money is not for the Tenants Association but only to pay salaries of the Manager of the Unit Reps. Mr. Harold Jackman, - Secretary Mrs. Ginger Gibbons, - 24 Tenant Unit Reps. - 4 Tenant Representatives on the Management Advisory Committee - Plus Administrative expenses concerning the contract.

The revised Constitution of the Regent Park Tenants Association was passed on June 18th, Candidate and General Membership Meeting. The Major changes are as follows:

Any person living in Regent Park 18 years of age and over may join the association by paying a membership fee of 50 cents a year.

The Unit reps, will be signing up members over the summer months. The reasons for having paid membership is so that we will have an accurate picture of tenant involvement and commitment to the association, also to build a strong paid membership and unite all agencies, committees and off-shoots functioning in Regent Park under the Umbrella of the Tenants Association for better communication for all. Members will have the following privileges: (a) notification by letter of all General Membership Meetings, members are entitled to attend all meetings of the association

(b) Vote in annual elections and for all committees, boards established by the association and on any issue to be decided by the association. (c) Eligible to run for any office in the Association. (d) Receive minutes of all meetings. (e) Participate in all activities of the Association. (f) Children of members may attend the annual childrens Xmas Party. Members must join at least thirty (30) days prior to the annual elections.

Members will also elect the tenant members of the Regent Park Board of Directors which is the other major change in the constitution. The Board of Directors and the Executive of the R.P.C.I.A. shall be elected annually by the members of the association and shall have the authority to make the decisions for the association between General Membership Meetings. The Board will consist of the following tenants:

Six (6) from North Regent

Six (6) from South Regent

One (1) each from Service Unit, Adult Recreation Centre, Teen Project, Oak Community School, Regent Park Community News, Unit Rep. Committee, Health Centre, Senior Citizens, Council and the Six (6) members of the Executive of the R.P.C.I.A. President - 1st. Vice President - 2nd. Vice President - Treasurer - Recording Secretary and the Immediate past President.

The Tenants Association would like to congratulate the Senior Citizens Council on obtaining their New Horizons Grant. This Grant is to benefit all Senior Citizens of Regent Park and to provide recreation and facilities.

The evaluation made by the Tenants conducted by Dr. J. Frei, is finally ready and will be available to those who are interested in the achievements of the R.P.C.I.A. over the past 5 years. The tenants of Regent Park can be proud of these achievements.

The Office of the Association will be open during the summer months for tenants with inquiries and problems and will be staffed by Mr. Harold Jackman, - Manager of the Unit Reps. - and Mrs. Ginger Gibbons - Secretary. - and the Co-ordinator.

The Hiring Committee is interviewing Candidates for the position of Co-ordinator as the contract with the present co-ordinator has expired.

Candidates' Night IN REGENT PARK

On June 18, 1974 tenants in Regent Park had an opportunity to question and listen to candidates who represent their district Rosedale for the 1974 Federal Election, which will take place July 8th. They asked individual candidates what is their stand on several issues and also, if they would support certain proposals for improvement in conditions if they should be elected.

Candidates present were:

Hon Donald MacDonald	- Liberal Party
Mr Hal Jackman	- Progressive Conservative
Mr Maurice DesJardins	- New Democratic Party
Mr Marshall Bruce Evoy	- Libertarian Ind. Candidate
Mr Dan Golstick	- Communist Party
Mr Vernon Parker	- Marxist-Leninist Party

(absent)

Mr. Jackman was questioned first, concerning the rent brief entitled New Deal for Ontario Housing Tenants and which of the eleven recommendations he would support, and if elected what should he do to revise the rent scale.

Mr. Jackman expressed support for the rent brief of 20% of salary instead of the present rate, and would encourage desirable home purchases.

Mr. Maurice DesJardins N.D.P. answer to the rent brief question was that he supports all the recommendations. He thinks that the present scale must be eliminated and some upward allowance made before the overtime pay and supports ownership and 50% mortgage.

Mr. Evoy Independent, stated that he was sorry but he did not get to examine the brief as yet, so he would answer questions on inflation, wage and price controls, until he can study the brief.

Mr Dan Goldstick Stated that the brief should have requested less than 20% of net income. The audience roared their approval hearing this.

Mr. MacDonald Liberal

Question: At our candidates night in the last election you stated that you did not support the recommendation of 20% net income. In view of what has happened to our economy, since then, particularly the increase in the cost of food & clothing, are you still of the opinion that the present rent scale is fair?

He stated that actually, the rent scale rather than being either 20% or 25% varies according to the income.

Mr. MacDonald, does not support basing rents on net income because this would discriminate against larger families (the more dependents - the less income tax).

The President Mrs Janet Ross, drew Mr MacDonald's attention to the people on fixed incomes who are hardest hit, receiving monthly income of \$95. or \$105. The present rent scale requires 40% - 45% of their allowance and that this is again discrimination against those least able to pay.

Question: Mr. Jackman, will you support the continuation of L.I.P. Grants?

Mr. Jackman, did not commit himself on the continuation of L.I.P. he felt that too many projects were approved in Rosedale, by the Minister. Mr MacDonald argued that the grants were justified because they were for worthwhile projects like the Green Summer Day Camp.

Other questions concerned long waiting period for unemployment insurance, increase of price of gas and oil while Imperial Oil, has shown profits ranging from 400% - 700% in 1973; raffle system in selecting applications for H.O.M.E., R.P.C.I.A. request that tenants on Health Clinic Board be elected; a Post Office for Regent Park and Guaranteed income for people on fixed and low incomes; inflation and Price Control. All the candidates presented their programs on these matters.

The question period from the floor was lively but sometimes tense and proves that people are concerned about the serious economic changes in the country that is affecting their lives and their children's future.

The manager Mr. Jackman, is a very humble and approachable person, who will always listen to people's problems. We must make this programme work. For the whole of Canada is looking on. This is a challenge which we must accept. All Regent Parkers should be proud of our achievement. Let us prove to the critics, that ordinary people when given an opportunity can rise to great heights. Let us unite and go forward together. For in unity, lies our greatest strength Rise up Regent Parkers a new and brighter day has dawned for us.

Unit Rep. Duties

1. To be on duty for the Association at least three (3) hours per day, seven (7) days per week.
2. To inform tenants of the available services and facilities.
3. To welcome new tenants.
4. To discuss with tenants their responsibilities.
5. To co-operate with caretaking and maintenance staff and enlist the support of the tenants in improving the maintenance standards of the buildings.
6. To refer matters concerning security to the Unit Representative Committee, Tenant Security Committee and the Association. Unresolved matters will be referred to the Regent Park Management Advisory Committee.
7. To report tenants unresolved complaints to the Regent Park Management Advisory Committee after going through the established channels.
8. Upon request, to distribute materials of interest to the tenants.
9. To convene meetings of tenants to discuss common problems in their area.
10. To be available for extreme emergency calls during evenings and weekends. The Unit Representative shall have the Corporation's emergency numbers.

Representatives from the R.P.C.I.A. presented 10 children with awards at the Graduation Ceremonies this June. The children did not know in advance that they would be receiving the awards and so it was a wonderful surprise for them and their parents.

Mrs Phillips mother of Jody, was presented with a Plaque by Mrs. Florence Strudwick who said "On this very memorable day I share sad emotions with Mrs. Jeanette Phillips. It is also a very gratifying occasion because the memory of my daughter Carol Ann and Mrs. Phillips son Jody has inspired the residents of Regent Park to make these awards to children in our schools. It is a honour to present this plaque to you Mrs. Phillips as a permanent reminder of the fact that "the people of Regent Park do care."

Janet Ross, Harold Jackman, Neil Tanner, Ozzie Smith Roy Grennon from the executive and Marie Niven and Florence Strudwick, who headed the original committee took part in the ceremonies and the following statement was read:

The Jody Phillips Scholarship Award was established in June 1973 by the Regent Park Community Improvement Association and was announced publically at the opening of the Jody Phillips Swimming Pool, June 9, 1973

The money for this award was collected by tenants of Regent Park when nine year old Jody was killed on the railway tracks on his way home from a swimming pool on a hot day in the summer of 1969. Jody was not the first child of Regent Park to be killed in this tragic manner. The tenants of Regent Park were determined that his would never happen again. In a spontaneous demonstration led by Mrs. Florence Strudwick, whose daughter died saving another child's life and Mrs Marie Niven the tenants of Regent Park marched through Ward Seven and collected \$2,700. towards a swimming pool for Regent Park. Their goal was that children from this area would never again have to wander away from their home looking for a place to swim. This tragedy and the determination of the residents to obtain better facilities for their children influenced the three levels of government to provide Regent Park with a swimming pool.

The Regent Park Community Improvement Association in consultation with the tenants who raised the money agreed that the money should be used for scholarships for students in this area.

This money has been turned over to the Toronto Board of Education to keep in trust. Ten awards will be given to one boy and one girl from each of the five schools in the Regent Park area (Regent Park, Park School, St Paul's School, Lord Dufferin, and Sprucecourt.) for the next seven years. The committee is appealing for donations to increase the fund so that awards can be given over a longer period. These awards are for effort, determination and desire for education and is not for the student with the highest marks.

We hope that these awards will encourage children to further their education and to work to the best of their ability. There can be no finer tribute than that to the memory of Jody Phillips.

The school found Billy dependable, hard working and a boy who was eager to learn. He tries the task at hand even when he finds it difficult. Billy was responsive to the staff, and did the best he could at all times.

Spruce Court ZABIN RATTANSI MICHAEL SILLERS

Michael is one of three children attending Sprucecourt School. He comes from a one parent family living in Regent Park. He is an extremely polite, well disciplined boy. He is a very willing and dependable boy who has been helpful in and out of the classroom in a variety of ways. His school progress has been satisfactory. His mother seems quite interested in his welfare in school and seems to give him a great deal of encouragement towards school.

Zabin came to Canada with her mother and two older sisters from Tanzania in January of 1973. Can we afford six more years of waste?

We still have half a million Canadians unemployed and one out of every six families living below the poverty level. And what do we have to show for it? A bloated bureaucracy in Ottawa and runaway inflation for the rest of us.

During the past several months, I have visited every part of this riding, talking with people, listening to what they have to say.
