



Since the last edition of the "Dachi News", one gen-ral meeting of the membership has been held and one regular meeting og the Board.

General Meeting- June 12

The annual general meeting of the co-op was attended by thirty-three members of the co-op. The election of new - officers approval of part of the occupancy by-law and the appointment of a new auditor were the items transacted.

Chairman for the evening was Richard Griffiths. That was his last act for Dachi as he resigned from the Board as City of Toronto representative. In his place, Bev Marshall will serve.

After it was agreed that the general meeting had been given proper notice, the membership agreed to ratify the decisions of the outgoing Board. One of the policies in contention was that members who are in arrears should not sit on the Board. The membership agreed that this policy should be upheld.

Robert M. Veltheer, C.A. was appointed auditor for the next year.

Elected to the Board of Directors were: John Metson-Kay Battle, Liz Dance, Robert Spurll, Fran Rukevina, Grant Pattingale, Rudy Stocking, Krishna Gandhi, Mike Turner.

Items 1 to 45 of the Occupancy By-law werre accepted by the general membership with some minor modifications.

Meeting June 26 of new Board

The meeting was attended by all the new members of the Board as well as Carol Rushton, Judy Shipman, Carmel Hili, Bill Lee, Sharon Cunningham and Property Manager Helmut Soldwisch. Officers were elected for the coming year. John Metson was elected President for his second term. Krishna Gandhi was eelected vice-president, Grant Pattingale was elected secretary for the second time and Rudi Stocking was, again elected treasurer.

Rudi Stocking gave the financial report and explain-d why there was a difference between income and disbursements of \$3800. The reasons are: 1. there are seven vacancie-2. there was an abnormally high hydro payment and 3. the semi-annual insurance premiums were due.

Carmel Hili suggested that an Interim Vacancy Committee be formed.

The Information Committee gave its report. It will be sponsoring a Lawn Sale Jun July 15 and that ten percent of the money made will be turned over to Dachi. The Board commended the committee on its work for the June 12 13 Protest Rally. Later in the meeting, Sharon Cunningham presented her final report to the Board on the work of the Education Project.


The Occupany By-law, part 46-64 were approved by the Board and a special meeting of the membership will be held soon so that the general membership can ratify it.

A Smoke detector system for 18 Spruce was approved. The Fire Marshall had ordered that one be installed. The cost of the installation will be \$692. Members of the Board wish to encourage all members to make sure that the detector switches in their units are on.

The Maintenance Committee was instructed to review maintenance priorities.

In our last Newsletter issue, we had informed you about the new housing policy proposal of the Federal Cabanet. The Federation had examined this proposal and concluded it would affect adversely cooperative housing in the country. Thus, a lot of lobbying had been carried out to persuade Andre Ouellet, the Minister of State for Urban Affairs, to drop it. By way of adding more pressure on the Government, we were all asked to write to our MP or Mr, Ouellet to protest against this new programme. The Newsletter is carrying a sample letter; you are urged to copy it or write the ideas in it in your own words and send one of them to Parliament Hill.

Monourable Andre Ouellet, Misister of State for Urban Affairs, Ottawa, Ontario

Dear Minister,

He: Non-Profit Housing Programme 178

We have recently been informed of the details of the new programme and are writing to you to protest the programme immofar as it affects the non-profit continuing housing cooperatives. Insummary are some of the problems with the new programme 8

- By introducing the concept of 100% rent-geared-to-income into the housing cooperative you are totally destroying the basic concept that a non-profit cooperative provides housing at cost.
 - Secondly, you are not encouraging residents to be in any way cost conscious.
- Even with the maximum interest reduction grant that results in a (b) 2% mortgage rate the effect of your withdrawal from the rent supplement programme in cooperatives is to deny this housing to low income people
- (c) By insisting that people pay a minimum of 25% of their income for their housing you are discouraging moderate income earners from living in cooperatives, thereby undermining you own objective of "integration through income blending."
- (d) Then, you are also setting government policy that is deliberately in contradiction of the goal of insuring that Canadians do not pay more than of their income for shelter.
- (e) Even if we agreed withthe Federal Government proposals in principle, we feel that the administrative inghtmares implied in the management under your programme would be insurmountable. In particular, the concept of an interest subsidy that is adjusted annually based upon the income profile of the project is just not logistically feasible. If the cooperative and CMMC actually attempted to operate under this programme the administrative overheads would be far in excess of the present costs.

We have asked you national organization, the Cooperative Housing Foundation of Canada, to coordinate a comprehensive federal response to you, Mr. Minister. In the meantime, we ask that the federal government provide capital mortgage funds and operating subsidies at a level at least equivalent to the 1977 levels. This will allow the development of new projects while discussions are continuing on amendments to the Non-Profit Housing Programme of 1978.

Unless you act on our request immediately you will be permitting the end of the Cooperative Housing Programme.

We can send copies of paraphrased Versions of this letter to other interested parties like our local MP, local federal candidates, local coops and the Toronto Housing Cooperative Federation, the Coop Housing Coundation of Canada, the local media, and Resource groups.

The Government seems to be reacting to the pressure and has already decided that there will be no change in its cooperative housing policy till the end of 1978. Thus, more letters from us, the grass-roots, as bound to exert more positive influence on the government. Remember too that there is a federal election coming soon and the government is very sensitive to people's feelings about its policies.

So, take the time to write something. Dachi still needs federal money in order to develop, and we cannot receive that funding under impossible conditions.
