FEALTH BD. EXPOSED

Board of Directors has been pushing for answers from the Board of the Health Centre. When did they plan to become a Board truly representative of the people of Regent Park? When would they open up and start listening to staff? When would they stop using the Health Centre for political advantage?

To give you an inside look into these problems we make public the observation of Dr. Howard Krieger. Dr. Krieger resigned from the Health Centre staff Aug. 31/75. He is one of several people who no longer work at the clinic and whose departure is a loss to the Regent Park community. His resignation letter is also printed in this paper. Here is what he writes:

Some Background Information -Regent Park Community Health Cent-

Q. IS A COMMUNITY HEALTH CENTRE DIFFERENT FROM A PRIVATE DOCTOR"S OFFICE OR A HOSPITAL OR "PRIVATE" MEDICAL CLINIC? SHOULD IT BE DIF-FERENT AND IF SO IN WHAT WAYS? A. Yes, it must be different if it is going to meet the needs of community which has gone on for years as it is now without health professionals responding in any ade-

A. No! Of 18 members of the board of directors, only six are from Regent Park. One of these has since moved away. The participation of one other has not been fully welcomed. Only some of these people use the centre regularly for their medical are. Not one single person, except perhaps for the representative of the Regent Park Community Improvement Assoc. who is an ex-officio member of the board, can say that they speak ision for correcting this in the for the larger community. In what way do these people represent the wishes of the Regent Park community as a whole?

As early as Sept. 1973 the RPCIA

indicated that the Regent Park community was asking for a stronger voice in the running of "its" centre. At the time of the official opening in December 1973 this ever it was not even until early 1975 that by-laws were drafted to establish a structure to control who was eligible to sit on the board and how these people would be selected. There was, however, no provision in the draft by-laws for community elections or any defintion of who was eligible to be a member of the Health centre as a whole or of the board in particular. Upon being presented with these draft by-laws, the RP CIA in February asked for such changes. No response was made. Further request were made in April and May. In March the medicaldental staff of the centre asked for such changes. Furthermore, in April, the draft by-laws were passed intact. The result: no elections, no change in the composition of the board, no "unwelcome" input, no increase in the number of residents on the board, no provfuture. (continued on page 3).

DR. KRIEGER'S RESIGNATION LETTER

I am writing to you as Chairman of the Board of Directors of the Regent Park Community Health Centre to inform you formally that I shall be resigning my position as a physician at the Centre as of August 31st.

I am truly sorry to find myself in the position of having to make the decision and regret that I have to interrupt the many good relationships I have made with patients, fellow staff members and some members of the board.

Nonetheless there has also been a significant number of problems recognized by myself and the staff by what is taking place and this in general, particularly regarding remains the most regrettable fact board-staff and board-community relations which have made it increasingly difficult for me to provide that kind of care which I feel to be adequate and appropriate.

In addition, it has been made clear by the Administrator, presumably on your behalf, that the board is unhappy with by continuing presence as a physician. I had been interested in and excit-

ed by community health centres long before starting my work at Regent Park. This interest remains, at, perhaps, even a heightened level, which, of course, only serves to magnify the disparity between the way I feel community health centres should be organized to meet the needs of the communities which they serve and the way I perceive the board of Regent Park Community Health Centre has attempted to fulfil these services.

In the end it will be the people of Regent Park who are hurt most of all. Hopefully when all the staff vacancies are filled and when some of the policies of the centre are altered a more harmonious atmosphere will prevail and then the centre will be able to deal with the myriad problems presenting themselves each day.



PLANS FOR DUNDAS-REGENT CORNER *



The lot on the corner of Regent and Dundas Sts. next to St. Bart's Church is presently not being used to its full potential. The drawing you see in the paper is a propsal to take out the ball diamond there and replace it with a tennis court, two volley ball courts, two tetherball courts and two horse-shoe pits. One of the horse-shoe pits is regular size, and the other is a smaller size for children.

Tenant Management Report

Report on state of Management Contrat Negotiations - 1975-76

We wish to inform the residents of Regent Park that the negotiating team had four meetings with Ontario Housing officials from July 15th to August 10th. Copies of the RPCIA proposals were presented to Ontario Housing April 28th.

We have been informed that OHC lawyers are defining the legal ramification of the contract, and also that CMHC is requesting more data, on the success or failure of the program. The term of the first contract was from June, 1974 to May 31st. 1975.

Conflicting statements by the Corporation as to the reason for the delay in approving the contract, are cause for much concern.

The program is being continued on a month to month basis until a new contract is signed and implemented. We hope the latter phase of the program will be speedily concluded. The Association feels that this delay is a sign of bad faith negotiations on the part of Ontario Housing.

RENT SCALE

The following letter was sent to Premier Davis and his Housing Minister Irvine regarding the rent scale:

Dear Sir;

The rent scale for Public Housing is under review across the

country and Federation of Ontario Tenants Associations was asked to comment on the proposed changes in rent scale for Ontario.

It is the people with the lowest income who pay the highest percentage of income as rent. At present all Public Housing tenants earning a gross income of over \$404 monthly pay 25% of their income as rent but under the proposed new rent scale all Public Housing tenants, regardless of income will pay 25% of their income as rent.

The present inflationary economy has hit hardest at those who work in non-union positions or are living on a fixed income, and do not receive cost-of-living increases. The housing market is such that public housing tenants have no alternative but to remain in public housing. Public housing tenants are subsidizing, through their rent, other public housing tenants, but are still living under

Q. IS THE MEDICAL-DENTAL STAFF IN-VOLVED IN THE MANAGEMENT OF THE CENTRE?

A. No! The invitations that were at one time extended to certain meetings of the board were withdrawn either directly or indirect-ly. Since March 1975 the staff has petitioned the board to open up board meetings and the business of the centre in general to all interested staff members. Nor did the staff as a whole want to function through an "administrator", a person selected entirely by the board in the first place. What response there has been has felt to be inadequate by the staff. Q. WHO IS ACTUALLY DIRECTING THE BUSINESS OF THE REGENT PARK COM-MUNITY HEALTH CENTRE?

A. The last board meeting was in April 1975. Since the all the very very important negotiations with the Ministry of Health regarding funding for the year beginning October 1975 have been going on. Important decisions regarding the hours of the centre and the number of doctors and nurses have been made. A new doctor has been hired. Who has been doing all this? In no instance has the board as a whole made these decisions but rather a small group of board members who have decided that they can act for the whole board and speak for the whole of Regent Park. Are they really representing the people of Regent Park?

Q. HAS THE REGENT PARK COMMUNITY BEEN ALLOWED TO PARTICIPATE MEAN-INGFULLY IN THE MANAGEMENT OF THE HEALTH CENTRE? IS THE BOARD INTER-ESTED IN INCREASING THE EXTENT OF COMMUNITY RELATIONS INVOLVEMENT? WILL THE STAFF BE ALLOWED A MORE EXTENSIVE ROLE IN ADVISING ON

MANAGEMENT ISSUES?

A. The record shows clearly that the answer is no.

Q. WHAT IS GOING TO HAPPEN? A. Failure of the board to deal with all these has resulted in very very poor staff morale. Furthermore it appears that the funds for the coming year will approach only 60% of those obtained on an interim basis since January 1975 and only 45% of the funds for the first year of operation. In addition, there are many external problems that have not even been mentioned. Since January there has been 2 new administrators, one new doctor who is resigning soon, one doctor who resigned a few months ago, a third doctor who is also leaving soon, one new doctor hired only within

the past few weeks, one dentist w who resigned recently, a second dentist who is resigning soon (and

no new dentist hired as yet to replace either of these). One nurse is leaving and one or two others will have to be let go soon due to budget cutbacks. The present (fourth) administrator may also have to leave for the same reason. Obviously the centre cannot provide adequate service under these conditions. As the situation now exists one cannot be to optomistic about the future of the Regent Park Community Heal-

Q. WHAT NEEDS TO BE DONE?

A. There are many problems facing all health centres, both internal and external. There must be some definition of community and the tole of the community in the functioning of each centre. Full staff involvement must be ensured. Funding must recognize the special after six months. needs of the community served. It must be recognized that to meet these needs community health centres will not necessarily be cheaper, particularly at the beginning.

The board of the Regent Park Community Health Centre must establish that it truly represents the desires and needs of the people of Regent Park. Only full staff involvement will allow policies to be effectively transferred into practice. All community health centres can learn from the problems of Regent Park. the stigma of being themselves subsidized.

Because of the above reasons the delegates to the FOTA convention unanimously passed the FOTA Rent Scale, and rejected the one due to be proposed by OHC.

We are formally presenting to you, Mr. Premier, and to Housing Minister Donald Irvine, the proposed FOTA Rent Scale, copies of which are also being submitted to all political parties and candidat-

This presentation is certainly timely in lieu of your position, Mr. Premier, which you have taken

on inflation for your campaign; and because it dramatically affects the lives of many of the present residents of Ontario Housing, as well as all people who will, in the pursuit of clean, decent, safe and adequate housing as a social right, be housed in OHC houses.

FOTA, which represents collectively the interests of some 200, 000 Ontario tenants, will be holding a province-wide press conference on September 12th to comment on the program response made by all candidates, and to indicate our future course of action.

We feel it appropriate, at this time to raise the question of the Quality of Life, as reflected in the Rent Scale question, to all political candidates in the coming election, and to ensure, thr ough the press, that their response to this question reaches the tenants of Ontario, for their consideration.
